Auction Rules

BIDDING

1. All bidders must register and have an official bid number. By registering, each bidder agrees to abide by the rules listed below.
2. Each bidder must ensure they are bidding on the right item. Bidders should watch the auctioneer and the floor help holding the item for bid.
3. Bidders should check items before they bid. ALL ITEMS ARE SOLD AS IS, WHERE IS WITHOUT WARRANTY EXPRESSED OR IMPLIED.
4. No item is sold until the auctioneer says "Sold!" ALL SALES ARE FINAL. ALL SALES ARE ENFORCEABLE, COMPLETED TRANSACTIONS ONCE THE HIGHEST BID IS ACCEPTED BY THE AUCTIONEER.
5. Please dispose of your bidder number card as registered bidders are accountable for all purchase made with his/her bidder number.
6. The auctioneer and the owners of Auction Ventures reserve the right to remove any item from the auction before bidding starts on that item or any item that has a reserve price that has not been met. Merchandise may be added or deleted at any time prior to or during the auction.
7. Some auction lots will be sold as "bidder's choice." The highest bidder will have the choice of the lot or lots they want. The high bid is then multiplied by the number of chosen lots (example, high bid is \$10 and the bidder wants 5 lots, $\$10 \times 5 = \50 .) The auctioneer will announce bidder's choice when the items are placed for sale.
8. Websites or Inventory Listings may contain errors. Please check the merchandise and bid accordingly. The auctioneer will announce any known errors.
9. Once the auctioneer says "Sold", the merchandise is yours and will be given to you on general merchandise auction nights. On antique and collectibles auction nights, the small items will be placed in a secured section until the bidder pays for the item(s).
10. A seller may place a "reserve" bid for an item. They must obtain a certain price for the item. The auctioneer will announce all items that have a "reserve" bid.

PAYMENT

1. Buyers must pay for their purchases within one hour after the auction ends.
2. Buyers must pay for their purchases with either cash, cashier's check, certified check, money order, Visa, MasterCard, or Discover. A personal check will be accepted from local residents ONLY.
3. Any bad checks will be turned over for collection to the Jackson County Magistrate Court and the Jackson County, Georgia Sheriff's Office.
4. All records of sales will be kept by the Antique Venture, LLC staff and will be taken as final in the event of a dispute.

REMOVAL OF PURCHASED ITEMS

1. All purchases must be removed, entirely and with no abandonment, on the night of the sale and no later than 4 p.m. on the following day.
2. Any abandoned lots will be disposed of and charged to the buyer.
3. Buyers are responsible for making all arrangements and paying all costs for removing their items from the auction site. Arrangements to leave items on site past the deadline must be made after the auction with the Antique Ventures, LLC staff and is subject to the discretion of the staff and the storage fees as referred to in paragraph 7. Antique Ventures, LLC is not responsible for any items left on the premises.
4. Titles for any vehicles, boats or trailers or other equipment left onsite beyond the time allotted will be kept by Auction Ventures, LLC until the items are removed by the buyer.
5. Items left on the premises will be available for pickup only during designated auction pickup hours.
6. NO items will be left on site longer than two business days without accrual of storage fees even if permission has been given by the owners of Auction Ventures, LLC.
7. Purchased items left onsite by the buyer beyond two business days following the close of the auction will be subject to a storage fee of 10 percent of the auction sale price of that item for each day beyond two business storage days. All storage fees must be paid before items can be removed from the site.
8. After 10 days of storage fee accumulation, title to and ownership of any acquired item left onsite will be forfeited back to Antique Ventures, LLC as payment for the storage fees. The purchaser will not be entitled to any refund.

SAFETY

1. Antique Ventures, LLC is not responsible for any type of accident. Each bidder or visitor to the site known as Auction Ventures is responsible for his/her own safety around merchandise, equipment, vehicles, and other items to be auctioned. By registering to bid, the bidder voluntarily waives, releases and holds harmless Antique Ventures, LLC from any and all claims, causes of action and damages for bodily injury or death that the bidder may suffer as a result of, or in any manner connected with, directly or indirectly, the bidder's participation in the auction. In no event shall Antique Ventures, LLC be responsible for the safety of a bidder or for accidents or injuries to a bidder involving the items being sold at the auction. The bidder acknowledges that the waiver and release provided for herein precludes his/her right to recovery of damages in the event they are injured during the course of the auction.
2. Bidders who fail to comply with these auction rules are subject to being disqualified from this auction and any future auctions.
